Medico-legal report (as requested by a lawyer) – factual summary of history, symptomology, investigation, therapy, results and present condition. May contain estimate of date the person could return to work and perhaps a comment as to the likelihood of permanent disability*	Base fee: \$640.00 For each additional 15 minutes after 1 hour of practitioner's time: \$80.00

Liquid nitrogen treatment (wart/keratosis not on feet)	1 st lesion: \$15.00 Additional lesions: \$5.00 each (up to maximum of \$75.00)
Skin tag removal by electrocautery	1 st lesion: \$25.00 Additional lesions: \$10.00 each (up to a maximum of \$75.00/6 lesions total)
Cosmetic excision or lesion removal	1 st lesion: \$150.00 Additional lesions: \$50.00 each (up to a maximum of \$200.00/2 lesions total)
Single injection (i.e., vitamin B12, corticosteroid, Depo Provera, etc.)	\$10.00
IUD removal	\$15.00
